I. PUBLIC HEARINGS

HDC 17-07 – 15 Orchard Lane; Seamus O’Brien, owner; Andrew Acton, applicant; Deck repair. PIN #261806297673

Andrew Acton presented to the Commission for Seamus O’Brien owner of 15 Orchard Lane. He is proposing to replacing and repair an existing deck and concrete steps. The original pine deck posts have rotted and will be replaced with fiberglass posts that are essentially identical. The concrete stairs will be demolished and rebuilt with pressure treated 2x6 treads. The original pressure treated balusters and stair posts will be replaced with cedar that look the same. The decking will be straighted out so that the new posts and the roof above is level.

HDC 17-08 – 171 Candlewood Road; Wellspring Bible Fellowship, owner; Armstrong Chimney, applicant; Chimney. PIN #179020818594 E

Don Armstrong, of Armstrong Chimney & Stoves, presented to the Commission for Wellspring Baptist Church, which is located at 171 Candlewood Road. The top of the chimney is falling apart down to the roof line. The proposal is to rebuild it with brick that will have some color variation but from distance will not show any difference. The chimney will be 1’ taller with an additional 8” added from the chimney cap that is required per code. The plan is to use a granite stone cap.

An application for an addition and renovations that was previously approved also included replacement of the windows. The owners chose not to go forward with the project at the time and the COA has now expired. Currently, the Haberlandt's would like to replace the windows, remove the shutters, and then case or picture frame the new windows. In all, there are 26 windows to replace with approximately 6 differing sizes. All the sizes will be replaced like for like. The existing windows are Andersen with wooden sashes and they will be replaced with vinyl clad Andersen windows. A modified colonial design with dividers on top and clear glass on the bottom will be used.
